Our Purpose

Kids' Chance is a non-profit organization which provides educational opportunities through scholarships for the children of workers' seriously or fatally injured on the job. Kids' Chance of Illinois, a state organization, helps Illinois children pursue their dreams attending various institutions of higher education.

HISTORY

- Robert Clyatt, a workers' compensation attorney from Valdosta, Georgia, founded the first Kids' Chance organization in 1988.
- Over forty states and three affiliates have organized Kids' Chance programs that have collectively awarded over 6,597 educational scholarships and distributed over \$20,393,000 million in scholarship funds to workers' families since 1988.
- Since the early beginnings in 1988, Kids' Chance has grown and evolved, and has become a diverse group of employers, insurers, labor, state government, medical care providers, and both plaintiff and defense attorneys, who are working together to make a difference in the lives of all children affected by a workplace injury by helping them achieve their educational dreams.
- Kids' Chance of Illinois (KCOI) was established in 2012. Historically over 95% of funds raised were applied directly to support scholarships and our board is committed to this goal and maximizing the utilization of all funds raised to support our Kids' Chance Scholarship Recipients.
